20th El Paso USBC Annual Youth Championship Rules

1. Participation in the El Paso USBC Annual Youth Championship Tournament is open to any youth in the surrounding area holding a current El Paso USBC Youth or Special Olympics Membership and is in good standing. Proof of membership is required upon check-in.
2. This tournament will be USBC certified.
3. The *Gibby Daniels Scholarship Fund* will be donating \$2000 in scholarship money to the tournament.
4. Entering average will be based on the highest average of the following with a minimum 21 games:
 - a. Highest 2024-25 Book Average to include summer 2025.
 - b. Highest average on bowl.com for the current season.
 - c. If neither a or b apply, then current average as of January 13, 2026 with minimum of 6 games. Must bring current league standing sheet.
 - d. If bowlers do not meet the above requirements, they will use a 220 average.
 - e. USBC RULE 201c (Sport & Challenge averages) 1a-b shall apply. Also, USBC RULE 319a(2) (Averages: Conditions that apply) will apply.
5. This is a handicap tournament. Handicap will be 100% of 220.
6. This tournament is an **AWARD** and **SCHOLARSHIP** tournament. Scholarship money will be paid to all entries in a staggered system by division and event with the highest scores receiving a higher scholarship amount. Trophies to be provided for 1st and 2nd place only in each division and each event.
7. Tournament divisions are based on entry counts and averages with Youth Committee approval.
8. Entry fee for each event is \$18.00 (Lineage fee \$11.25, Expense fee \$1.00, Awards fee \$5.75). There is an optional All-Events fee of \$2.00.
9. **Closing date for entries will be January 15, 2026.**
10. Coaches must sign the entry form verifying averages. League standing sheets must accompany the entries with first and last names of bowlers for current average.
11. **CHECK-IN:** Check-in will be 60 minutes prior to squad start time. Coaches will have their teams ready to bowl and report to their lanes no later than 30 minutes prior to squad time. Coaches who did not submit a **fully/properly** completed entry form or require changes must report to Check-in no later than one (1) hour prior to squad start time.
12. Walk-ins or late arrivals will be accepted no less than one (1) hour prior to squad start time. Acceptance is dependent upon available spots.
13. Bowlers may enter Doubles event up to 6 times with a partner change each time. Singles may be entered up to 6 times. The highest score is only counted for awards in each division and each event.
14. **Bowlers must bowl 1 Singles and 1 Doubles Team to enter All-Events.**
15. Line up on the entry form will be the official line up and will not be changed except for substitutions. Substitutions will take the place of the regular bowler in the line up in the event of absenteeism. USBC RULE 322b (Absentee/Vacancy) shall apply. Once a substitute has replaced a bowler, that substitute will stay in the line up for the series.
16. Three games will be bowled in each event.
17. Bowlers must use hand delivery which they established average with throughout the entire tournament.
18. No food or drinks will be allowed in the bowler's settee area.
19. There will be no use of tobacco products or alcoholic beverages by any youth member or spectator on or behind tournament lanes occupied by a youth member (bowler).
20. No electronic devices will be allowed in the bowler's settee area.
21. No gambling will be allowed during the tournament (e.g., playing cards).
22. Only bowlers participating in that shift and tournament staff (displaying proper RVP certification) are allowed in the settee area.
23. Proper attire must be worn.
 - a. SHIRTS – Bowling Jersey or acceptable Polo or colored T-shirts. All shirts must have finished sleeves.
 - b. PANTS – Pants, Jeans & Leggings must be fitted at the waist and in good repair. Active wear & sweatpants are not permitted. For Skirts, Capris, Skorts, or walking pants the bowler's fingertips must not touch skin when holding hands loosely at their sides.
 - c. Hats and headgear are not permitted. Ear plugs or muffs of non-electronic type will be permitted for special needs.
 - d. No attire that may be construed as offensive may be worn.
- e. There will be no exceptions. Tournament Management has the authority to disqualify any bowler for not following proper dress code.

Coaches are responsible to make sure their bowlers adhere to the dress code prior to check-in.

24. All bowling balls must meet USBC specifications (RULES CH. 8 – Equipment Specifications). Bowlers are only permitted to change the surface of the bowling ball prior to competition. After the competition begins, no changes to the bowling ball's surface will be permitted. (RULE 18 – Bowling Ball/Altering Surface).
25. Proper conduct is expected (RULE 17d – Youth Conduct). Tournament Management has the authority to disqualify any bowler for not following proper conduct.
26. All current USBC Tournament and Conduct Rules, not specified in these rules, will apply. All USBC and Tournament Rules will be enforced. Tournament Management has final say on any rule not specifically covered herein (RULE 303 - Management).
27. Any Championship Tournament participant who violates the rules will be disqualified from the tournament for that day.
28. All protests must be made by bowlers according to USBC RULE 329 (Protests and Appeals).
